2025: Tariff-Driven Inflation Lifts (Nearly) All Revenue Boats

Welcome to Modern Distribution Management's 2026 Top Distributors feature, now in its 17th year. Here, you'll find our rankings of North America's largest distributors of industrial, commercial and building supply products, based on their 2025 fiscal revenue within 20 different industry verticals. More than 220 different companies are represented across these various lists between this PDF report and corresponding web listings.

It's MDM's biggest research project of the year.

Before you dive into our rankings in the pages ahead, I want to set the stage for the key factors that shaped this year's feature and the context you should know when perusing our lists.

Since our lists are based purely on 2025 fiscal revenue for all distributors, that year is worth examining from a high level.

After 2024 marked the first relatively "normal" year for U.S. wholesale distributors since the COVID-19 pandemic in terms of major industry-wide disruption, 2025 business conditions were defined by one word: tariffs.

Distributors knew tariffs were coming with the Trump administration taking office in January of 2025, and that policy kicked into high gear on April 2's "Liberation Day". But no one could have predicted the roller coaster of major policy that ensued in the months after.

Shifting tariff proposals, uneven implementation timelines and uncertainty around product-level exposure created a difficult backdrop for pricing strategy. Distributors were forced to make fast decisions on whether to absorb higher costs, pass them through to customers or hold pricing in place to protect demand — often before they had full visibility into supplier actions or competitive response.

That volatility complicated margin management across the channel. Many distributors found themselves recalibrating price lists, surcharge mechanisms and customer communications more frequently than normal, while sales teams worked to explain cost changes in a market where buyers were already sensitive to inflation. The result was a year in which pricing discipline became both more important and harder to execute.

As 2025 progressed, inflation-driven revenue gains became increasingly visible. Over the final eight months of the year, higher realized prices helped lift topline results across much of wholesale distribution, even as underlying volume growth remained uneven by sector. By year-end, the industry's revenue scale reflected not only demand resilience but the cumulative impact of tariff-related cost pressure, broader inflation and the pricing actions distributors took to preserve profitability.

This was all against a relatively muted industrial demand backdrop that many publicly traded distributors described as "sluggish" in their quarterly earnings calls throughout 2025 for most durable goods categories.

U.S. wholesale distribution revenue finished 2025 at \$8.44 trillion — a new annual high water mark for the industry — up 4.8% compared with 2024. But again, inflation did most of the heavy lifting. Exemplifying distribution's fragmentation and diversity, certain industry sectors saw excellent 2025 growth led by electrical and electronics riding the data center demand wave, while building materials/construction saw continued decline against a difficult housing market.

The vast majority of the distributors on our lists in the pages ahead posted annual sales gains in 2025, and lasting high inflation has the industry set for major revenue growth in 2026. As of mid-June, MDM expects overall U.S. wholesale distribution revenue to increase by high-single digits annually, likely topping the \$9 trillion mark this year.

is best known as an electrical products distributor, but its industrial products sales were large enough to chart at No. 13 on our Industrial Supplies list. It's also why Ferguson appears on our lists for Industrial Supplies, Building Materials/Construction and Safety, besides its hallmarks of Plumbing, HVACR and Industrial PVE.

But while our rankings are based on 2025 revenue within each sector, the revenue you see displayed on our lists is overall revenue. Why? Quite simply, while many privately-owned distributors elected not to publicly share their total revenues, far fewer elected not to publicly share their sector-specific revenues. If we displayed the sector-specific revenues of those that gave us the OK to, they'd be few and far between. The overall revenue figure gives us something to show for a considerable portion of companies on our lists, though an increasingly larger amount elect to keep their private.

That sector-specific revenue breakout is the most painstaking part of our research process, as it involves an incredible amount of hair-splitting and triangulation to find accurate revenues. It makes this feature all the more challenging, but we do it because it results in a more accurate list and levels the playing field.

Industry-Specific Revenue

Like for the past several years, this is the most important part of this introduction. Starting in 2022, MDM put a heightened emphasis on ranking companies by their sector-specific revenues rather than total revenue.

This also explains why you'll see some distributors with smaller total revenues ranked higher than others within the same industry.

Take Grainger, for example. By its total 2025 revenue of \$17.9 billion, Grainger is North America's largest industrial supplies distributor. But when digging into its financial reports and product sector breakouts, we find that it's also one of North America's top distributors of electrical, HVACR, plumbing, power transmission, fluid power and safety products. This is why Grainger appears on 10 of our 20 sector lists — the company's revenue within each of those segments is large enough to warrant a spot. And this is why Watsco is ranked No. 1 in HVACR and Grainger is No. 5. Despite Watsco's \$7.2 billion revenue being much smaller than Grainger's — Watsco's HVACR revenue was much higher than Grainger's.

This explains why you'll find some companies charted on industry lists outside of their "core" offering. For example, Graybar

Our Top Distributors Research Process

MDM's Top Distributors Lists were based on 2024 fiscal revenues within industry sectors, either reported or estimated by MDM's editorial team and sector validators. For distributors that don't follow a January-December fiscal calendar, we've noted that with an asterisk and a footnote. To normalize the way we display the rankings, we include total company revenues, rather than breaking out individual sector revenues. Companies were asked to provide data about revenue, with information supplemented by quarterly fiscal reports, SEC filings and publicly available information. For companies that elect to not share revenue data, MDM estimates their relative position in its sector list based on the best available industry resources and information.

Most companies see little or no year-to-year movement for their list positions(s), but some see large jumps or slides up/down our lists. Often, that's not necessarily due to performance, but due to MDM finding better, more accurate information for their revenue than in the year prior.

Note: Companies that operate primarily as master distributors are not eligible for Top Distributors inclusion.



Where's Amazon Business?

MDM readers who have regularly seen our Top Distributors lists over the years may notice that we don't include the industry's biggest elephant in the room: Amazon Business. The B2B supplies marketplace appeared in the top six of our Top Industrial list since first appearing in 2018, including at No. 2 in 2022. But while the platform is certainly competing directly with industrial, commercial and building supply distributors for market share to a tune of \$35 billion in 2022 revenue, we made the decision in 2023 to omit it from our lists due to Amazon Business' very unique business model. It was the only company on our lists in previous years that couldn't be described as a distributor. We do, however, include The Home Depot's Pro component, which directly operates via distribution sales, services and logistics after recent acquisitions that include Interline Brands, HD Supply (re-acquired), SRS Distribution and GMS.

Keep in Mind

As you peruse our rankings across these different verticals, it's important to remember that the way we put them together is not an exact science. Our editorial team made every effort to extract revenue information from the non-publicly traded distributors listed here, but many companies are understandably private with that information. We are happy to keep their revenue strictly private and only use it internally for rankings, which a number of companies opt for each year. So, when you see "N/A" listed for revenue, that likely means that revenue figure was confidentially given to MDM and to not be published.

Even with that understanding, a smaller number of companies would rather not budge on sharing their revenue at all. Given the number of large distributors that have been privately acquired in recent years, this isn't a surprise. In these cases where revenue isn't shared, our team triangulates with respected industry experts and the best available information to estimate and rank distributors appropriately.

Another nugget to note is that since we used fiscal 2025 revenue for all companies, the revenue of a handful of companies that don't follow a traditional 12-month fiscal calendar represents a time difference by as much as nine months. But to simplify things, we used 2025 fiscals for all companies.

As alluded to above, there is no perfect way to conduct these rankings. I'm sure there are MDM readers who will disagree with where and how certain companies are slotted on our list, and that's OK, especially given our focus on sector-specific revenue. For MDM, MRO products are those needed to keep a company's facilities and production processes running smoothly, whereas industrial products encompass MRO in addition to products involved in the manufacturing process and/or components used in the final product.

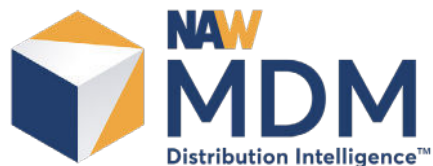
